A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AN EIGHTH AMENDMENT TO THE AGREEMENT WITH IMS RECYCLING SERVICES AND ALLAN COMPANY FOR PROCESSING, TRANSPORTING AND MARKETING COMMINGLED CURBSIDE RECYLABLES.

WHEREAS, the City of San Diego (City) requires the continued services of a contractor to process, transport, and market the recyclable materials collected in the City's curbside recycling program; and

WHEREAS, in October 1998, after completion of a competitive request for proposal process, the Council of the City of San Diego (Council) authorized a revenue-generating agreement with IMS Recycling Services and Allan Company (Contractor) to process, transport, and market the recyclables collected by the City in its curbside recycling program (Agreement); and

WHEREAS, pursuant to the Agreement, the Council authorized seven subsequent amendments to modify and extend the Agreement; and

WHEREAS, the City and Contractor have negotiated amendments to certain sections of the Agreement to extend the term of the Agreement for up to two (2) additional months while the City processes a Request for Proposals for a new contract for processing, transporting, and marketing commingled curbside recyclables; and

WHEREAS, on April 18, 2019, the Environment Committee unanimously recommended approval of this item; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor or his designee is authorized to execute, for and on behalf of the City, an eighth amendment to the

Agreement with IMS Recycling Services and Allan Com	pany to process, transport, and market
recyclable materials collected in the City's curbside recyc	cling program, under the terms and
conditions set forth in the Eighth Amendment, on file in	the Office of the City Clerk as
