A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING CHANGE ORDER NO. 5 WITH TC CONSTRUCTION COMPANY FOR THE RESTORATION OF SURFACE PAVEMENT FOR THE NAVAJO PUMP STATION PROJECT.

WHEREAS, this request is to authorize Change Order No. 5 for the Navajo Pump Station construction contract between the City of San Diego and TC Construction Company, Inc. (TC Construction) which the City will pay TC Construction an agreed amount of \$1,033,986.52 to pay for additional street resurfacing work on Lake Murray Drive, Mewall Drive, and Lake Arrowhead Drive within the vicinity of Navajo Pump Station project (Project); and

WHEREAS, this change order will extend the construction contract and with this change order, the revised Total Construction Cost will be \$9,840,928.44 with a Total Project Cost to \$11,720,405; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Mayor, or his designee, is authorized to execute Change Order No. 5, to TC Construction Company, Inc. for an amount not to exceed \$1,033,986.52, under the terms and conditions set forth in the document filed with the City Clerk as Document No. RR-312447
- 2. That the Chief Financial Officer is authorized to expend an additional amount not to exceed \$751,933.52 from, AA #A-ID.00005-Street Resurfacing and Reconstruction (B19011, Trench Paving Group 1901), Fund 200203, Transportation & Storm Water Department and \$282,053.00 from CIP A-BJ.00001 Water Pump Restoration (B11023, Navajo Pump Station), Fund 700010, Water Utility CIP for Change Order No. 5, provided that the Chief Financial

Officer furnishes one or more certificates demonstrating that the funds are, or will be, on deposit in the City Treasury.

3. That the Chief Financial Officer is authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
