THE FREEWAY AGREEMENT WITH THE CALIFORNIA
DEPARTMENT OF TRANSPORTATION FOR
STATE ROUTE 56.


WHEREAS, this item is to amend an existing Freeway Agreement with the California
Department of Transportation (Caltrans) for State Route 56 (SR-56) to reflect the new
overcrossing over SR-56 from the Torrey Meadows Drive Overcrossing project; and

WHEREAS, as the result of new overcrossing over SR-56, Caltrans requires that the City
approve a resolution amending the existing Freeway Agreement together with the revised
Exhibit A map to include the new overcrossing and the agreement itself is remaining unchanged
except for updating Exhibit A; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his
designee, is authorized to approve and execute, for and on behalf of the City, the proposed
revision to the existing State Route 56 (SR-56) Freeway Agreement with Caltrans as reflected in
attached Exhibit A, for the Torrey Meadows Drive Overcrossing project, on file in the Office of
the City Clerk as Document No. RR 312448.



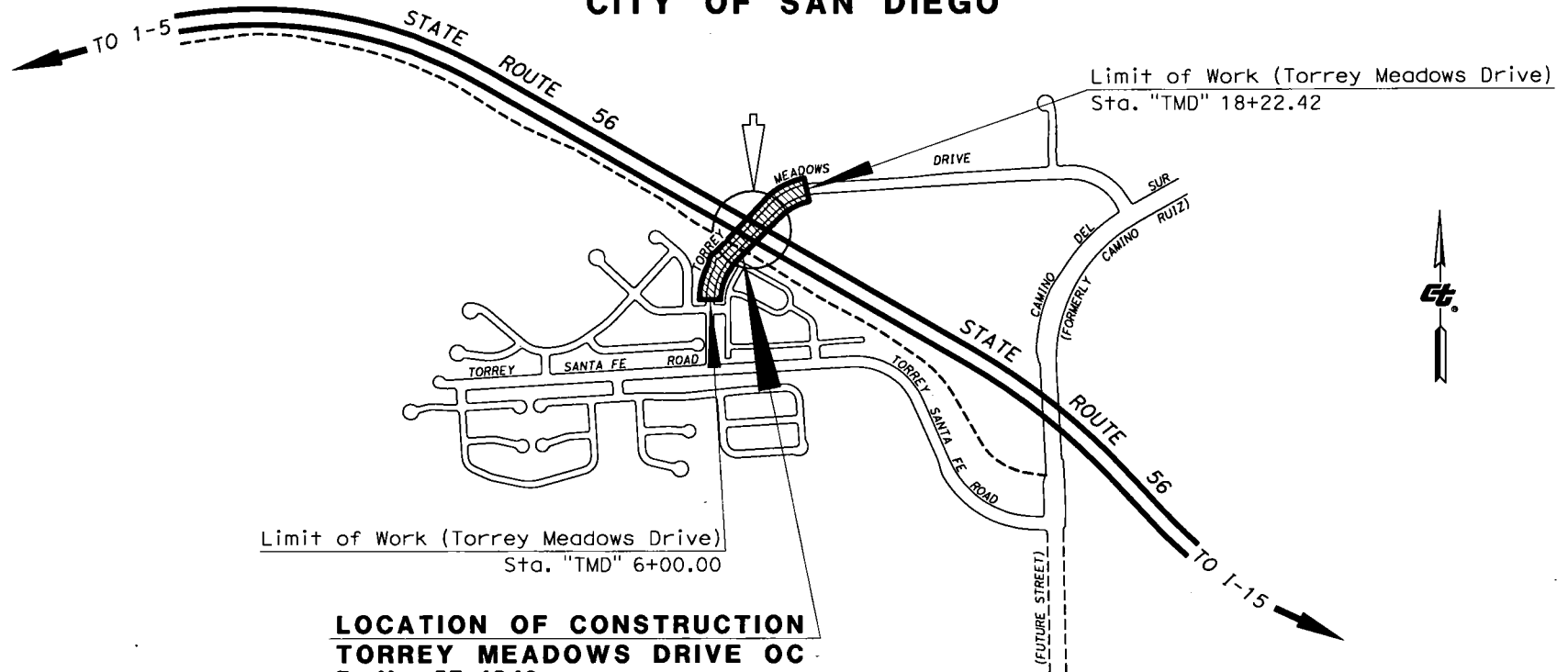







Limit of Work (Torrey Meadows Drive)


