A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A CONSTRUCTION AGREEMENT FOR THE MONTEZUMA/MID-CITY PIPELINE PHASE 2 AND 70TH-ALVARADO TO SARANAC SIDEWALK (K-19-1821-DBB-3) PROJECT; AND TAKING RELATED ACTIONS.

WHEREAS, the Montezuma/Mid-City Pipeline Phase 2 and 70th-Alvarado to Saranac-Sidewalk project will provide approximately 4,900 feet (0.93 miles) of 66-inch diameter cement mortar-lined and concrete (CMLC) steel pipeline as a parallel and redundant conveyance system to the Trojan Pipeline. It also includes installing new concrete sidewalk on the west side of 70th Street between Alvarado Road and Saranac Street; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the plans and specifications for construction of Montezuma/Mid-City
  Pipeline Phase 2 and 70th-Alvarado to Saranac-Sidewalk, as advertised by the Public Works
  Department, are approved.
- 2. That the Mayor, or his designee, is authorized to execute a construction contract with the lowest responsible and reliable bidder for an amount not to exceed \$48,800,000, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasury, under the terms and conditions set forth in the Agreement, on file in the Office of the City Clerk as Document No. RR-312459
- 3. That the Chief Financial Officer is authorized to expend an amount not to exceed \$48,800,000, of which \$48,550,000 is from CIP S-11026 (Fund 700010, Water Fund), Montezuma/Mid-City Pipeline Phase 2 and \$250,000 is from CIP B-17065, 70th-Alvarado to

Saranac-Sidewalk for the purpose of construction of the project, contingent upon the

Chief Financial Officer first furnishing one or more certificates demonstrating that funds

necessary for expenditure are, or will be, on deposit with the City Treasury.

4. That the Chief Financial Officer is authorized to expend funds under the

established contract funding phases in a total amount not to exceed \$48,800,000; of which

\$13,250,000 for the first phase, and \$35,550,000 is for all subsequent phases in S-11026 (Fund

700010, Water Fund), Montezuma/Mid-City Pipeline Phase 2 and B-17065, 70th-Alvarado to

Saranac-Sidewalk, contingent upon adoption of the Annual Appropriation Ordinance for the

applicable fiscal year, and contingent upon the Chief Financial Officer furnishing one or more

certificates certifying that the funds necessary for expenditure under the established contract

funding phases are, or will be, on deposit with the City Treasury.

5. That the Chief Financial Officer is authorized, upon advice from the
