A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING EXECUTION OF SEPARATE AGREEMENTS WITH ALLSTATE SECURITY SERVICES INC. AND LOCATOR SERVICES, INC., DBA ABLE PATROL AND GUARD FOR THE PROVISION OF SECURITY GUARD SERVICES.

WHEREAS, on August 12, 2018, the City of San Diego (City) issued Request for Proposal (RFP) No. 10089334-18-M for security guard services at various City facilities; and

WHEREAS, the City facilities were separated into eight sections: Section 1: Library, Section 2: Parks & Recreation and Community Parks, Section 3: Development Services Center, Section 4: Parks & Recreation, Balboa Park, Section 5: Rose Canyon Operations Yard, Section 6: 20<sup>th</sup> & B, Section 7: Civic Center, City Administration Building, and Office of the City Treasurer, and Section 8: Homelessness Initiative Sites, and the RFP allowed for multiple contract awards by section and each section corresponded to specific City facilities outlining the specific scope of work for each City facility; and

WHEREAS, based on the results of the competitive bid process, the City requests the approval of a Resolution to authorize the Mayor or his designee to execute two separate agreements: (1) Allstate Security Services, Inc. to provide security guard services for Sections 1 and 3 through 8 in an amount not to exceed \$24,910,721 over the five-year term of the contract; and (2) Locator Services, Inc., dba Able Patrol and Guard to provide security guard services for Section 2 in an amount not to exceed \$1,933,660 over the five-year term of the contract; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee is authorized to execute, for and on behalf of the City, the agreement between the City and Allstate Security Services, Inc. to provide security guard services, in an amount not to exceed \$24,910,721 over the five-year term of the agreement, under the terms and conditions set forth in the agreement, on file in the Office of the City Clerk as Document No. RR-

BE IT FURTHER RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee is authorized to execute, for and on behalf of the City, the agreement between the City and Locator Services, Inc., dba Able Patrol and Guard to provide security services, in an amount not to exceed \$1,933,660 over the five-year term of the agreement, under the terms and conditions set forth in the agreement, on file in the Office of the City Clerk as Document No.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$24,910,721 over the five-year term of the Agreement with Allstate Security Services, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year, and contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$1,933,660 over the five-year term of the Agreement with Locator Services, Inc., dba Able Patrol and Guard, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year, and contingent upon the Chief Financial

Officer first furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
