DATE OF FINAL PASSAGE MAY 22 2019

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A JOINT USE AGREEMENT WITH THE CITY OF CHULA VISTA FOR REAL PROPERTY IN THE FUTURE EXTENSION OF FAIVRE STREET BETWEEN BROADWAY AND FOURTH AVENUE IN THE CITY OF CHULA VISTA, IN RELATION TO THE CITY OF SAN DIEGO'S EXISTING 27-INCH OTAY VALLEY TRUNK SEWER.

WHEREAS, the City of San Diego (City) owns and maintains the existing 27-inch Otay Valley Trunk Sewer within the City of Chula Vista; and

WHEREAS, the 27-inch Otay Valley Trunk Sewer is located within an existing City of San Diego easement; and

WHEREAS, the 27-inch Otay Valley Trunk Sewer alignment is located within the future road improvements of Faivre Street in the City of Chula Vista, and no realignment of the existing 27-inch Otay Valley Trunk Sewer is required for these future road improvements; and

WHEREAS, the City will continue to operate and maintain the 27-inch Otay Valley Trunk Sewer both in its existing easement and within the future road segment of Faivre Street between Broadway and Fourth Avenue, south of Main Street; and


WHEREAS, the City and the City of Chula Vista desire to set forth their respective rights and obligations regarding the construction, operation, and maintenance of the 27-inch Otay Valley Trunk Sewer and the City of Chula Vista's facilities within the future road segment of Faivre Street between Broadway and Fourth Avenue, south of Main Street; NOW,

THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his designee, is hereby authorized and directed to execute the Joint Use Agreement by and between

the City of Chula Vista and the City of San Diego, on file in the Office of the City Clerk as Document No. RR- 312474, setting forth their respective rights and obligations in the event of actual or potential present or future conflicts in the construction, operation, or maintenance of their respective facilities as a result of the future road segment of Faivre Street between Broadway and Fourth Avenue, south of Main Street, and in relation to the City of San Diego's existing 27-inch Otay Valley Trunk Sewer.


