A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING AN ADDITIONAL \$5,000 FROM COUNCIL DISTRICT 4 TO CONNECTING HOPE COMMUNITY DEVELOPMENT CORPORATION/UMBC FOR THE PROJECT CLEAN UP JOB EMPLOYMENT PROGRAM, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the Connecting Hope Community Development Corporation (CDC)/UMBC has requested funding for the Project Clean Up Job Employment Program; and

WHEREAS, the Connecting Hope CDC/UMBC has already received funding from Council Districts 2, 4 and 9 in the total amount of \$33,500, which was approved by Council on April 9, 2019 (Item 125); and

WHEREAS, Council District 4 would now like to allocate an additional \$5,000, which, along with the funding that has already been given to Connecting Hope CDC/UMBC, will be used to employ 25-30 youth for 120 hours, to assist with community enhancement projects such as hauling away unwanted items and assisting community seniors in the improvement of abandoned homes by repairing fences, broken windows and other community eyesores; and

WHEREAS, Connecting Hope CDC/UMBC's request for funding for the Project Clean Up Job Employment Program will benefit the public by allowing at risk populations a chance to be gainfully employed, receive work preparedness training and an opportunity to invest in the area of which they live in; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 4 recommends an additional amount of \$5,000 (in addition to the \$12,500 already allocated from Council District 4); NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 8, which provides: "Community Projects, Programs and Services funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2019 City Council Allocations Agreement between the City of San Diego and the Connecting Hope CDC/UMBC (Agreement) in an amount not to exceed \$5,000 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 312475

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$5,000 from Council District 4: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1104110004 GL512059 to provide funds for

the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
