A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO AUTHORIZE EXECUTION OF THE SECOND AMENDMENT TO THE AUTHORIZED USER AGREEMENT FOR THE NASPO VALUEPOINT COOPERATIVE PROCUREMENT AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND CELLCO PARTNERSHIP D/B/A VERIZON WIRELESS FOR CELLULAR EQUIPMENT AND SERVICES.

WHEREAS, effective as of June 6, 2017, the City of San Diego (City) entered into the Authorized User Agreement with Cellco Partnership d/b/a Verizon Wireless for use of the NASPO ValuePoint Cooperative Procurement Agreement for cellular services and equipment (Agreement); and

WHEREAS, the First Amendment to the Agreement was approved by Council Resolution RR-311743, and made effective on June 11, 2018; and

WHEREAS, as provided for in Section 22.3208 of the San Diego Municipal Code, the City's Purchasing Agent certified in writing that use of the NASPO ValuePoint Cooperative Procurement Agreement is in the City's best interests, to the City's economic advantage, and the agency's contract was awarded using a process that complies with the City's policies, rules, and regulations; and

WHEREAS, the City now wishes to increase the Agreement's not-to-exceed amount to a total of \$7,650,000 during the full term of the Agreement, extend the term of the Agreement through December 31, 2019, and to otherwise modify the Agreement in accordance with the terms and conditions set forth in the Second Amendment to the Agreement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his

designee is hereby authorized to execute, for and on behalf of the City, the Second Amendment

to the Authorized User Agreement for the NASPO ValuePoint Cooperative Procurement

Agreement between the City of San Diego and Cellco Partnership d/b/a Verizon Wireless

pursuant to the terms and conditions contained in the original Second Amendment to the

Agreement on file in the Office of the City Clerk as Document No. RR- 312490.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend

an amount not to exceed \$7,650,000 over the full term of the Agreement for funding Verizon

Wireless services and equipment, contingent upon adoption of the annual Appropriation

Ordinance for the applicable fiscal year, and upon the Chief Financial Officer furnishing one or

more certificates certifying that funds necessary for expenditure are, or will be, on deposit with

the City Treasurer.
