amendment to be consistent with the General Plan; and

Whereas, the 2008 General Plan will be amended because the Otay Mesa Community

Plan is part of the Land Use Element of the adopted General Plan; and

hearing on the community plan amendment and considered all maps, exhibits, and written

documents contained in the file for this project on record in the City of San Diego, and has
