A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING A MEMORANDUM OF
UNDERSTANDING BETWEEN THE CITY OF SAN DIEGO
AND THE DEPUTY CITY ATTORNEYS ASSOCIATION
REGARDING TERMS AND CONDITIONS OF EMPLOYMENT
FOR FISCAL YEAR 2020.

WHEREAS, by San Diego Resolution R-310511, the San Diego City Council (Council) approved a Memorandum of Understanding between the City of San Diego (City) and the Deputy City Attorneys Association (DCAA) regarding terms and conditions of employment for employees represented by DCAA for Fiscal Years 2017 through 2019; and

WHEREAS, Article 4 of the Memorandum of Understanding provides a reopener to negotiate proposals for a successor Memorandum of Understanding (MOU) for Fiscal Year 2020; and

WHEREAS, beginning February 5, 2019, the City and DCAA met and conferred pursuant to the reopener provision and reached a tentative agreement on May 21, 2019 for a successor MOU that is intended to take effect July 1, 2019 through June 30, 2020; and

WHEREAS, employees represented by DCAA ratified the tentative agreement on June 3, 2019; and


WHEREAS, the total estimated increased cost for the general salary increases in the MOU is \$1.68 million; and

WHEREAS, the estimated impacts to the San Diego City Employees' Retirement System due to pensionable pay increases will need to be estimated by an actuary; and

WHEREAS, under the Meyers-Milias-Brown Act (MMBA), the state law related to collective bargaining between the City and its represented employees, and Council Policy 300-06, it is within the discretion of the Council to approve the MOU; NOW, THEREFORE,

BE IT RESOLVED, pursuant to the authority of the MMBA and Council Policy 300-06, the Council of the City of San Diego approves the MOU between the City and DCAA for Fiscal Year 2020, on file in the Office of the City Clerk as Document No. RR- 312536.
