A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING TASK ORDER NO. 5 TO RAMONA PAVING AND CONSTRUCTION CORP. FOR CONSTRUCTION SERVICES UNDER JOB ORDER CONTRACT K-18-6888-JOC-3-A FOR RESIDENTIAL BLOCK UU854 BLOCK 2BB JOB 1 (CROWN POINT).

WHEREAS, the Utilities Undergrounding Program initiates projects in accordance with Council Policy 600-08 and the Underground Utilities Procedural Ordinances, and then procures services necessary to complete the undergrounding work; and

WHEREAS, the Block 2BB Job 1 Project is an Underground Utility District that was previously approved by Council in January 2018 (R-310995), and this action seeks the approval of Task Order No. 5 for Job Order Contract (JOC) K-18-6888-JOC-3-A with Ramona Paving and Construction, Corp. (R-311508); and

WHEREAS, the work to be performed by this task order is the construction of utility services on private property within the Underground Utility District, which is necessary to connect residents and businesses to the underground utilities that are being constructed or will be constructed within the street right-of-way; and

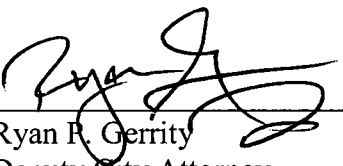
WHEREAS, San Diego Municipal Code Chapter 2, Article 2, Division 31 City Manager's Authority to Award Task Orders Under Job Order Contracts requires Council approval of task orders over \$1,000,000 for all work other than asphalt paving and pipeline work; and

WHEREAS, the total authorization being sought for Task Order No. 5 for the Project is \$3,235,688.47 and requires approval by the Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The Mayor or his designee is authorized to award Task Order No. 5 UU854 Block 2BB Job 1 (Crown Point) under Job Order Contract (JOC) K-18-6888-JOC-3-A for an amount not to exceed of \$3,081,608.07 to Ramona Paving and Construction Corp.
2. The Chief Financial Officer is authorized to expend funds in an amount not to exceed \$3,081,608.07 using Underground Surcharge Fund (200217), to fund Job Order Contract (JOC) K-18-6888-JOC-3-A, Task Order No. 5, for the project titled "UU854 Block 2BB Job 1 (Crown Point)."
3. The Mayor or his designee is authorized to execute Task Order modifications in a total amount not to exceed \$154,080.40, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasury.
