A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO AUTHORIZE EXECUTION OF THE ASNEEDED AGREEMENT WITH DUDEK TO PROVIDE ENVIRONMENTAL PLANNING CONSULTANT SERVICES FOR THE CITY OF SAN DIEGO PUBLIC WORKS DEPARTMENT.

WHEREAS, the City utilizes the As-Needed Environmental Planning Consultant
Services agreement to perform various environmental planning studies in support of the
execution of its Capital Improvement Program (CIP) and other general public projects. AsNeeded consultants provide professional environmental planning services within specific
disciplines for Citywide projects. To design or construct a typical project, the City utilizes
consultants that specialize in providing biological, historical, cultural, paleontological and other
environmental resource services; and

WHEREAS, this Agreement will retain the services of an environmental planning firm-to provide professional environmental planning consultant services on an As-Needed, hourly fee basis. The maximum agreement cost shall not exceed \$5,000,000, and the agreement has a maximum duration of five years; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, the Mayor, or his designee, is authorized to execute an agreement with Dudek to provide As-Needed Environmental Planning Consultant Support Services in an amount not to exceed \$5,000,000.00 which is contingent upon the Chief Financial Officer first furnishing one or more certificates demonstrating that funds necessary for expenditure are, or will be, on deposit with the City Treasury, under the terms and conditions set forth in the Agreement, on file in the Office of the City Clerk as Document No. 2574

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend

an amount not to exceed \$5,000,000.00 over five years for the purpose of funding the As-Needed

Environmental Planning Consultant Support Services agreement with Dudek contingent upon the

adoption of the Annual Appropriation Ordinance for the applicable fiscal year and contingent

upon the Chief Financial Officer furnishing one or more certificates certifying that funds

necessary for expenditure are, or will be, on deposit with the City Treasurer; and

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend

an amount not to exceed \$1,000.00 from CIP A-CA.00001, Drainage Projects, (B14078,

Jamacha Drainage Channel Upgrade), Fund 400265, GFCIP Contributions for the purpose of

executing this agreement and meeting minimum contract requirements.
