A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AMENDING THE LAND DEVELOPMENT
MANUAL BY ADDING APPENDIX R: CITY OF SAN DIEGO
WIRELESS COMMUNICATION FACILITIES (WCF)
GUIDELINES.

WHEREAS, on June 6, 2019, the Planning Commission of the City of San Diego recommended that the Council of the City of San Diego (Council) approve an ordinance to amend the Municipal Code and Local Coastal Program with respect to the regulations applicable to wireless communication facilities (WCF Ordinance); and

WHEREAS, a new Appendix R entitled “City of San Diego Wireless Communication Facilities (WCF) Guidelines” is proposed to be added to the Land Development Manual to provide applicants with information to assist them in determining if a proposed design complies with the applicable regulations; and

WHEREAS, San Diego Municipal Code section 111.0106 provides that the City may establish and adopt submittal requirements, review procedures, and standards and guidelines for development to supplement the Land Development Code to be known as the Land Development Manual; and

WHEREAS, on July 23, 2019, the Council held a public hearing for the purpose of considering the WCF Ordinance and the new Appendix R to the Land Development Manual;

NOW, THEREFORE

BE IT RESOLVED, by the City Council of the City of San Diego, that the Land Development Manual is hereby amended by adding a new Appendix R entitled “City of San

Diego Wireless Communication Facilities (WCF) Guidelines," a copy of which is on file in the office of the City Clerk as Document No. RR- 312583.
