A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO PURSUANT TO SECTION 147(f) OF THE INTERNAL REVENUE CODE OF 1986 REAPPROVING THE ISSUANCE OF BONDS BY THE HOUSING AUTHORITY OF THE CITY OF SAN DIEGO FOR THE EAST BLOCK FAMILY APARTMENTS.

WHEREAS, the Housing Authority of the City of San Diego (Authority) intends to issue not to exceed \$24,000,000 principal amount of multifamily housing revenue bonds (Bonds) to finance the acquisition and construction of the East Block Family Apartments, a multifamily affordable housing project in the City of San Diego (City) described in the Notice of Public Hearing attached as Exhibit A hereto (Project); and

WHEREAS, the City Council adopted San Diego Resolution R-31256 With a date of final passage on JUL 19, 2019 (Prior Resolution) approving the issuance by the Authority of the Bonds; and

WHEREAS, prior to the adoption of the Prior Resolution, the City Council held a public hearing regarding the Project following reasonable public notice as required by section 147(f) of the Internal Revenue Code of 1986 (Code), in order for interest on the Bonds to be tax-exempt; and

WHEREAS, at the time of the publication of the notice of the public hearing that occurred before adoption of the Prior Resolution, the Project was anticipated to be located at the

northwest corner of Fairmount Avenue and El Cajon Boulevard, and the address of the location of the Project has now been determined to be 4340 44th Street; and

WHEREAS, in light of the recent determination regarding the address of the Project, under applicable provisions of the Code the issuance of the Bonds must be reapproved by the City Council after a new public hearing following reasonable public notice; and

WHEREAS, one or more notice(s) of a new public hearing with respect to the proposed issuance of the Bonds with the revised address for the Project were timely published in accordance with said section 147(f); and

WHEREAS, the new public hearing was held on July 30, 2019, and an opportunity was provided for interested persons to express their views on the issuance of the Bonds and on the nature and location of the Project; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that this City Council, as the applicable elected representative under section 147(f) of the Code, approves the issuance of the Bonds by the Authority.

BE IT FURTHER RESOLVED, that the City does not warrant the creditworthiness of the Bonds or guarantee, in any way, the payment of the Bonds. No moneys of the City will be pledged or applied to the repayment of the Bonds.

BE IT FURTHER RESOLVED, that action being taken pursuant to this Resolution at this time involves only consideration of the approval of the issuance of the Bonds, and so is not a

"project" and is therefore not subject to the California Environmental Quality Act (CEQA) pursuant to State of California CEQA Guidelines Section 15060(c)(3).
