A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THAT PRIOR ENVIRONMENTAL DOCUMENTS ADEQUATELY ANALYZED THE MODERATE INCOME HOUSING REGULATIONS.

WHEREAS, the City Council, as the Lead Agency and using its independent judgment, by Resolution Nos. R-303473, R-308015, and R-98-288 adopted on March 10, 2008, March 4, 2013, and November 18, 1997, respectively, certified Environmental Impact Report EIR No. 104495/SCH No. 2006091032; 2013 Addendum to the 2008 General Plan Environmental Impact Report No. 104495/SCH No. 2006091032 for the General Plan Housing Element Update; the Land Development Code Environmental Impact Report No. 96-0333/SCH No. 96081056; and the Climate Action Plan PEIR (California Environmental Quality Act (CEQA) Documents), copies of which are on file in the Office of the City Clerk; and

WHEREAS, in connection with the considerations of the Land Development Code, General Plan, and Climate Action Plan Projects, the City Council considered the issues discussed in the CEQA Documents; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the information contained in the CEQA Documents, including any comments received during the public review process, have been reviewed and considered by this Council and it is determined that no substantial changes or new information of substantial importance within the meaning of CEQA Guideline section 15162 would warrant any additional environmental review in connection with approval of the amendments to the Land Development Code Moderate Income Regulations.

BE IT FURTHER RESOLVED, that the City Clerk is directed to file a Notice of Determination (NOD) with the Clerk of the Board of Supervisors for the County of San Diego regarding the above action.


