A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO ADOPTING AN AMENDMENT TO THE  
CLAIREMONT MESA COMMUNITY PLAN AND GENERAL  
PLAN.

WHEREAS, on August 1, 2019, the City Council of the City of San Diego held a public hearing for the purpose of considering an amendment to the Clairemont Mesa Community Plan and General Plan for purposes of mobility plan changes and other actions associated with the Balboa Avenue Station Area Specific Plan; and

WHEREAS, the current Clairemont Mesa Community Plan was adopted in 1989 and last amended in 2011; and

WHEREAS, on December 13, 2018, the Planning Commission of the City of San Diego held a public hearing to consider the proposed Balboa Avenue Station Area Specific Plan and associated amendments to the Clairemont Mesa Community Plan; and

WHEREAS, the Planning Commission recommended certification of Final Environmental Impact Report Project No. 586601/SCH No. 2017071007 prepared for the proposed Balboa Avenue Station Area Specific Plan; and

WHEREAS, the City Council found, based on its hearing record, that the proposed Clairemont Mesa Community Plan amendment is consistent with and implements the City of San Diego's General Plan and that the proposed plan amendment helps achieve long-term community and city-wide goals for purposes of mobility plan changes; and

WHEREAS, the City Council has considered all maps, exhibits, and written documents contained in the file for this project on record in the City of San Diego, and has considered the oral presentations given at the public hearing; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego that it adopts the amendment to the General Plan and to the Clairemont Mesa Community Plan, a copy of which is on file in the Office of the City Clerk as Document No. RR- 312606.

BE IT FURTHER RESOLVED, that this Resolution shall take effect when Ordinance OO- 21120, adopting the Balboa Avenue Station Area Specific Plan, is effective.
