A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING AND RATIFYING AN AGREEMENT BETWEEN THE CITY AND THE SAN DIEGO THE CALIFORNIA TEAMSTERS LOCAL 911 RELATED TO THE ESTABLISHMENT OF AN INTERIM DEATH AND DISABILITY PLAN FOR EMPLOYEES INITIALLY HIRED ON OR AFTER JULY 20, 2012.

WHEREAS, by San Diego Resolution R-310148 (December 16, 2015), the San Diego City Council (Council) approved and ratified a Memorandum of Understanding between the City of San Diego (City) and the California Teamsters Local 911 (Local 911), setting forth the terms and conditions of employment for Local 911-represented employees for Fiscal Years 2017 through 2020 (MOU); and

WHEREAS, San Diego City Charter (Charter) section 151, which was added to the Charter by the adoption of the Proposition B initiative in June of 2012, states that the City may provide employees initially hired after July 20, 2012 (Proposition B's effective date) with disability benefits if they become disabled by reason of bodily injury or illness; and

WHEREAS, Article 4, section F, and Exhibit E of the MOU provide that the City and Local 911 will meet and confer during the term of the MOU, at the request of either party, over implementation of death and disability benefits for employees initially hired on or after July 20, 2012; and

WHEREAS, the City has met and conferred with Local 911 and reached an agreement to implement an Interim Death and Disability Benefits Plan for employees initially hired on or after July 20, 2012; and


WHEREAS, in order to implement the Interim Death and Disability Benefits Plan, this Agreement requires a separate Council resolution approving an amendment to add a new Article VI to the City's Self-Funded Employees' Long-Term Disability Income Plan document; and

WHEREAS, this Agreement has been negotiated pursuant to the Meyers-Milias-Brown Act (MMBA) and Council Policy 300-06 and is subject to council approval to take effect; and

WHEREAS, the Council desires to approve and ratify the Agreement; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that pursuant to the MMBA and council Policy 300-06, the Council approves and ratifies the Agreement between the City and Local 911, related to the establishment of an interim death and disability plan for employees initially hired on or after July 20, 2012, on file in the Office of the City Clerk as Document No. RR-312622.
