A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT BETWEEN JULIO GONZALEZ AND THE CITY OF SAN DIEGO

WHEREAS, on February 18, 2018, Julio Gonzalez [Plaintiff] filed suit against the City of San Diego [City] alleging damages resulting from violations of the Fair Employment and Housing Act while employed as a Water Systems Technician III with the Public Utilities

Department between March 2014 to March 2016. Plaintiff brought suit in the Superior Court of the County of San Diego. The suit is entitled *Julio Gonzalez v. City of San Diego, San Diego Superior Court Case No. 37-2018-00005751-CU-WT-CTL* [Litigation]; and

WHEREAS, in Closed Session on July 16, 2019, the City Council approved the settlement with the following votes: Yeas: Districts 1, 2, 3, 4, 5, 6, 7, 8 and 9; Nays: None; and Absent: None;

WHEREAS, the City Council in Closed Session on July 16, 2019, authorized settlement of the Litigation against the City for an amount consistent with the amounts set forth below; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$175,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the lawsuit filed by Julio Gonzalez for violations of the Fair Employment and Housing Act, entitled *Julio Gonzalez v. City of San Diego*, San Diego Superior Court Case No. 37-2018-00005751-CU-WT-CTL.

- 2. Authorizes the Chief Financial Officer to expend \$175,000.00 from Public Liability Fund No. 720045, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
- 3. Authorizes the Comptroller to issue a check in the amount of \$175,000.00, made payable to Jackson Law, APC Client Trust Account fbo Julio Gonzalez.
