A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE ESTABLISHMENT OF FEES FOR ELECTRIC PERSONAL ASSISTIVE MOBILITY DEVICE BUSINESSES FOR INCLUSION IN THE RATEBOOK OF CITY FEES AND CHARGES MAINTAINED IN THE OFFICE OF THE CITY CLERK.

WHEREAS, the proposed Ordinance Permitting Electric Personal Assistive Mobility

Device Businesses, Ordinance No. O-_______, which is considered along with this resolution, establishes a permit process and regulation of businesses that offer for rent one or more electric personal assistive mobility devices in the City of San Diego (City); and

WHEREAS, it is the policy of the City to establish fees to recover the costs of providing services in accordance with San Diego Administrative Regulation 95.25 and Council Policy 100-05; and

WHEREAS, the City conducted a full evaluation of the costs and revenues associated with permitting these businesses, in accordance with the California Constitution; and

WHEREAS, Administrative Regulation 95.25 encourages transferring specific fee schedules listed in the San Diego Municipal Code and Council resolutions to the Ratebook of City Fees and Charges maintained in the Office of the City Clerk; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that upon the effective date of the Ordinance Permitting Electric Personal Assistive Mobility Device Businesses, Ordinance No. O- 2.1.2.30, the permit fee of \$53 is adopted to recover the reasonable costs incurred by the City in permitting electric personal assistive mobility device businesses.

BE IT FURTHER RESOLVED, that the City Clerk is directed to amend the Ratebook of City Fees and Charges maintained in the Office of the City Clerk to include the permit fee authorized by this Resolution.
