A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT BETWEEN RASEAN JOHNSON AND THE CITY OF SAN DIEGO

WHEREAS, on February 28, 2017, Rasean Johnson [Plaintiff] filed suit against the City of San Diego [City] alleging damages resulting from violations of Title VII of the Civil Rights Act of 1964. Plaintiff brought suit in the United States District Court, Southern District of California. The suit is titled *Rasean Johnson v City of San Diego*, U.S. District Court Case No. 17cv410 L (NLS) [Litigation]; and

WHEREAS, in Closed Session on August 6, 2019, the City Council approved the settlement with the following votes: Yeas: Districts 1, 2, 3, 4, 5, 6, 7, 8 and 9; Nays: None; and Absent: None; and

WHEREAS, the City Council in Closed Session on August 6, 2019, authorized settlement of the Litigation against the City for the amount consistent with the amounts set forth below;

NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$565,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the Litigation.

- 2. Authorizes the Chief Financial Officer to expend \$565,000.00 from Public Liability Fund No. 720045, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
- 3. Authorizes the Department of Finance to issue a check in the amount of \$298,000 made payable to Rasean Johnson.
- 4. Authorizes the Department of Finance to issue a check in the amount of \$267,000 payable to Smith Steiner Vanderpool, APC, for the payment of attorney fees and costs.
