A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AMENDING THE MISSION VALLEY COMMUNITY PLAN AND AMENDING THE GENERAL PLAN TO EFFECT A COMPREHENSIVE UPDATE TO THE MISSION VALLEY COMMUNITY PLAN.

WHEREAS, on September 10, 2019, the City Council of the City of San Diego held a public hearing for the purpose of considering amendments to the Mission Valley Community Plan and General Plan and other actions associated with the comprehensive update to the Mission Valley Community Plan; and

WHEREAS, the current Mission Valley Community Plan was adopted in 1985 and encompasses parcels within Mission Valley; and

WHEREAS, this update creates a new community plan for the Mission Valley community in order to recognize its unique land use and urban form characteristics; and

WHEREAS, as part of the plan update, the City's General Plan will be amended due to the Community Plan being part of the adopted General Plan; and

WHEREAS, the Planning Commission of the City of San Diego held a public hearing on June 20, 2019, to consider the amendments to the Mission Valley Community Plan; and

WHEREAS, the Planning Commission found, based on its hearing record, that this comprehensive community plan update is consistent with and implements the City of San Diego's General Plan and Climate Action Plan and that the proposed update helps achieve long-term goals within the community, as well as meets city-wide goals; and

Environmental Impact Report (Project No. 518009/Sch. No. 2017071066) prepared as part of

this project; and

WHEREAS, on February 21, 2019, the Airport Land Use Commission determined that

the proposed Mission Valley Community Plan is conditionally consistent with the San Diego

International Airport ALUCP and Montgomery-Gibbs Executive Airport ALUCP, with the

condition that future construction within the project area complies with the airspace protection

policies of the applicable ALUCP, including obtaining and complying with the conditions of a

determination of no hazard from the Federal Aviation Administration (FAA) for any project

meeting FAA notice criteria; and

WHEREAS, the City Council has considered the Planning Commission record and

recommendation as well as the maps, exhibits, and written documents contained in the file for

these updates on record in the City of San Diego, and has considered the oral presentations given

at the public hearing; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mission

Valley Community Plan incorporates the policies of the City of San Diego General Plan and

Climate Action Plan.

BE IT FURTHER RESOLVED, that the City Council of the City of San Diego hereby

updates the Mission Valley Community Plan and amends the General Plan, a copy of which is on

file in the office of the City Clerk as Document No. R- 312654
