A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO ACCEPTING A STRATEGIC PLAN TO
ADDRESS HOMELESSNESS TITLED "THE CITY OF SAN
DIEGO COMMUNITY ACTION PLAN ON HOMELESSNESS".

WHEREAS, the San Diego Housing Commission (Housing Commission), on behalf of the City of San Diego, contracted with Corporation for Supportive Housing (CSH), a nationally recognized consultant with broad expertise in the area of homelessness, for the development of a comprehensive strategic plan for the City to address homelessness; and

WHEREAS, CSH worked with a steering committee that consisted of key staff members from major funding and policy-making agencies within the City of San Diego; and

WHEREAS, the objective of this effort was to develop a comprehensive strategy, which identifies actionable approaches to address short-term and long-term homelessness issues; and


WHEREAS, the Housing Commission is presenting The City of San Diego Community Action Plan on Homelessness drafted by CSH to the San Diego City Council for acceptance, which document is on file with the City Clerk as RR-312700(Strategic Plan); and

WHEREAS, the Strategic Plan recommends five key strategies, which are subdivided into several priorities and identifies actionable approaches to address short-term and long-term homelessness issues; and

WHEREAS, the Housing Commission recommends that areas of focus within the Strategic Plan be assigned to specific City Council committees, which will provide oversight and direction toward the implementation of the Strategic Plan; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that The City of San Diego Community Action Plan on Homelessness is accepted and City staff and the Housing Commission are directed to bring actionable items and updates identified in the Plan to the appropriate Council committees for further consideration.
