A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE RETENTION OF TELECOM LAW FIRM, P.C. AS OUTSIDE COUNSEL FOR OPPOSING THE WIRELESS INFRASTRUCTURE ASSOCIATION AND CELLULAR TELECOMMUNICATIONS AND INTERNET ASSOCIATION PETITIONS FOR DECLARATORY RULING FILED WITH THE FEDERAL COMMUNICATIONS COMMISSION.

WHEREAS, the City of San Diego has reviewed the petitions for declaratory ruling filed with the Federal Communications Commission by the Wireless Industry Association (WIA) and Cellular Telecommunications and Internet Association – The Wireless Association (CTIA) in WT Docket No.: 19-250 (Petitions), and has determined that the City should oppose the petitions as part of a coalition of local governments in order to prevent further erosion of local regulation related to the siting and aesthetics of certain types of wireless communication facilities; and

WHEREAS, due to the unusual and complex nature of the legal issues involved in representing a coalition of local governments in opposing rulemaking proceedings in administrative proceedings at the FCC, the City Attorney's Office does not have the necessary expertise to advise the City on and prepare and submit comments and reply to comments on the Petitions; and

WHEREAS, due to a heavy workload, the City Attorney's Office does not have the necessary staff to prepare a comment letter, review all of the comments submitted to the FCC in the administrative proceedings, and prepare a reply to comments in order to ensure that the administrative record contains factual and legal information that the FCC should consider in ruling on the Petitions within the very short time frame that the FCC has provided for comments and reply comments; and

governments that wish to oppose the petition and the fee for retaining the Telecom Law Firm is

less than \$25,000.00, which pursuant to San Diego Municipal Code section 22.3208(a) may be

WHEREAS, Telecom Law Firm, P.C. has the necessary skills and experience to assist

the City in this matter; and

WHEREAS, the anticipated amount for this engagement is \$3,500.00, to be paid from

General Fund 100000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the City Attorney's

Office is authorized to retain Telecom Law Firm as outside counsel to provide legal services to

oppose the WIA/CTIA Petitions for Declaratory Rulemaking filed with the FCC in WT Docket

No.: 19-250 through the notice-and-comment procedure in the administrative proceedings on

behalf of the City as part of a coalition of local governments.

BE IT FURTHER RESOLVED, by the Council of the City of San Diego that the Chief

Financial Officer or his designee is authorized to appropriate and expend an amount not to

exceed \$3,500.00 from the General Fund 100000 for the retention of Telecom Law Firm, P.C. as

outside counsel, contingent upon the Chief Financial Officer first issuing one or more certificates

certifying that the funds necessary for expenditure are, or will be, on deposit in the City

Treasury.
