A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AND DIRECTING EXECUTION OF A MEMORANDUM OF AGREEMENT WITH THE COUNTY OF SAN DIEGO FOR PUBLIC HEALTH AND ENVIRONMENTAL HEALTH SERVICES.

WHEREAS, in 1953, the San Diego City Council (Council) authorized the County of San Diego (County) to provide general public health services within the City of San Diego through the Basic Agreement for Public Health Services to be Furnished by the County to the City of San Diego (Basic Agreement); and

WHEREAS, in 1977, the Council authorized a Second Basic Agreement for Public

Health Services to be Furnished by the County to the City of San Diego (Second Basic

Agreement), which superseded the Basic Agreement and included environmental health services
as a component of the County's public health services; and

WHEREAS, the Second Basic Agreement has been in full force and effect since 1977; and

WHEREAS, on November 5, 2018, by Resolution R-312024, the Council reaffirmed the City's commitment to a contractual relationship with the County for public health services under the state law and the Second Basic Agreement; and

WHEREAS, on March 27, 2019, the City and County entered into a Memorandum of Understanding to Ensure Awareness and Appropriate Response in Public Health Matters (MOU) to clarify the roles and responsibilities of the parties in routine or emergency public health matters, with the understanding that a revised, more formal agreement would follow; and

WHEREAS, the Memorandum of Agreement for Public Health and Environmental

Health Services (Agreement) would supersede the Second Basic Agreement and the MOU and

memorialize the responsibilities of the City, County Public Health Officer, and County

Department of Environmental Health and how these parties communicate with each other; and

WHEREAS, the City will continue to vest full authority in the County's Public Health

Officer and Director of Environmental Health to perform functions described in the Agreement

and in state and local law; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his

designee, is authorized and directed to execute that certain Memorandum of Agreement for

Public Health and Environmental Health Services between the City of San Diego and the County

of San Diego, the terms and conditions of which are more fully set forth in Document

No. RR- 312754 on file in the Office of the City Clerk.
