DATE OF FINAL PASSAGE DEC 12 2019

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AN AGREEMENT WITH CLEAN HARBORS ENVIRONMENTAL SERVICES, INC. FOR HOUSEHOLD HAZARDOUS WASTE MANAGEMENT, TRANSPORTATION AND DISPOSAL SERVICES; AND RELATED FUNDING ACTIONS.

WHEREAS, the City of San Diego's (City) Environmental Services Department requires the household hazardous waste management, transportation, and disposal services (Services) of an environmental firm in order to implement the City's Household Hazardous Waste Element which is a requirement of the 1989 California Integrated Waste Management Act; and

WHEREAS, in July 2019, the City, through the Purchasing & Contracting Department, advertised a Request for Proposals (RFP) for the Services to enter into a two-year agreement with three additional one-year options to renew; and

WHEREAS, Clean Harbors Environmental Services, Inc. submitted a bid in response to the RFP and was selected as the most qualified firm to provide the Services; and


WHEREAS, the Environment Committee heard this item on November 7, 2019, and unanimously recommended that the Council of the City of San Diego approve the contract award to Clean Harbors Environmental Services, Inc.; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his designee, is authorized to execute, for and on behalf of the City, an Agreement with Clean Harbors Environmental Services, Inc., for household hazardous waste management, transportation, and disposal services, for a period of two years, with three additional one-year options to renew, in an amount not to exceed \$6,000,000 during the term of the Agreement,

under the terms and conditions set forth in the Agreement on file with the City Clerk as Document No. RR- 312756.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$6,000,000 from the Refuse Disposal Fund No. 700039, the Recycling Fund No. 700048, and the CalRecycle Used Oil Payment Program Grant Fund No. 710001, solely and exclusively to provide funds for the Agreement, contingent upon City Council approval of the Annual Appropriations Ordinance for the applicable fiscal years, and contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.


