DATE OF FINAL PASSAGE DEC 12 2019

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A FIRST AMENDMENT TO THE COOPERATIVE PROCUREMENT CONTRACT WITH REHRIG PACIFIC COMPANY FOR WASTE CARTS, RECYCLING CARTS, CART PARTS, BINS & RELATED PRODUCTS AND SERVICES TO INCREASE THE NOT-TO-EXCEED EXPENDITURE AUTHORITY; AND RELATED FUNDING ACTIONS.

WHEREAS, the City of San Diego's (City) Environmental Services Department requires waste carts, recycling carts, cart parts, bins and related products and services; and

WHEREAS, in January 2018, the City, through the Purchasing & Contracting Department, executed a cooperative procurement contract pursuant to San Diego Municipal Code section 22.3208, Administrative Regulation 35.11, and Council Policy 100-01 with Rehrig Pacific Company for waste carts, recycling carts, cart parts, bins and related products and services in an amount not-to-exceed \$3,000,000 (Contract); and

WHEREAS, the City and Rehrig Pacific Company desire to enter into a First Amendment to the Contract to increase the not-to-exceed expenditure authority of the Mayor or designee to \$8,545,000; and

WHEREAS, the Environment Committee heard this item on November 7, 2019; and unanimously recommended that the Council of the City of San Diego approve the First Amendment to the Contract to increase the not-to-exceed expenditure authority to \$8,545,000;


NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his designee, is authorized to execute, for and on behalf of the City, the First Amendment to the

Contract to increase the not-to-exceed expenditure authority during the term of the Contract to \$8,545,000, under the terms and conditions set forth in the First Amendment to the Contract on file with the City Clerk as Document No. RR- 312760.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$8,545,000 from the Automated Refuse Container Fund No. 200302 and the Recycling Enterprise fund No. 700048, solely and exclusively to provide funds for the Contract, contingent upon City Council approval of the Annual Appropriations Ordinance for the applicable fiscal years, and contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
