A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR OR HIS DESIGNEE TO APPROVE A TUITION FEE INCREASE TO THE JUNIOR LIFEGUARD PROGRAM AND REFUND POLICY.

WHEREAS, the San Diego Junior Lifeguard Program (JLGP) offers San Diego youths an opportunity to learn and train with professional lifeguards; and

WHEREAS, the JLGP consists of a team of lifeguard professionals who provide aquatic education to San Diego youth while developing confidence, mental and physical fitness, and respect for one another and the coastal environment; and

WHEREAS, during two separate rigorous four-week long sessions, and a week-long introduction class to ocean awareness, junior lifeguards gain a wide variety of skills and knowledge; and

WHEREAS, activities include ocean safety and awareness education, how to enjoy the beach safely, water rescue techniques, familiarity with local beaches, maintaining mental and physical fitness, environmental awareness, healthy habits, first aid skills, open water swimming, surfing, paddling, snorkeling, CPR training, cliff rescue, SCUBA familiarization, visiting San Diego's local beaches, and other skills to prepare them for life; and

WHEREAS, each summer the program enrolls approximately 1000 paying students and provides over 50 scholarships; and

WHEREAS, youth ranging from ages 7 to 17 can enroll in the program; and WHEREAS, the program is cost recoverable as stated in Resolution R-307343; and

WHEREAS, due to increases in hourly salaries for labor costs and an increase in fringe costs within the City of San Diego, the cost of running the JLGP has increased; and

WHEREAS, in order to maintain the program's target of cost recovery, the San Diego Fire-Rescue Department (SDFD) is requesting a tuition fee increase; and

WHEREAS, revenues will continue to be collected through JLGP tuition and be expended in that program with no impact to the General Fund; and

WHEREAS, approved by voters in 2010, California Proposition 26 amended articles XIII A and XIII C of the California Constitution to provide that a levy, charge, or exaction of any kind of fee imposed, increased, or extended by a local government is a tax, requiring two-thirds voter approval, unless an exception applies; and

WHEREAS, exceptions to Proposition 26 include user fees for government services to specific payors who request the benefit or service and the fee does not exceed the reasonable cost of providing the service; and

WHERAS, permissible user fees for government services are government-provided recreational, cultural, educational, and similar programs; and

WHEREAS, it is the policy of the City to establish fees to recover the costs of providing services in accordance with the City of San Diego Administrative Regulation 95.25 and Council Policy 100-05; and

WHEREAS, it is the policy of the City to review fees to ensure that all reasonable costs incurred in providing these services are being recovered; however, it is also the policy that fees are generally less than 100 percent cost recovery in cases where the purpose of the fee is not to generate revenue but rather provide benefits to the recipients (e.g. recreational activities); and

WHEREAS, the tuition fee adjustment for FY 2020 does not exceed the reasonable costs

of providing the Junior Lifeguard Program and the Junior Lifeguard Program is not 100 percent

cost recoverable; and

WHEREAS, a City staff report from SDFD substantiates the validity of the proposed

increase in the Junior Lifeguard Program tuition fee for FY 2020 by explaining the link between

the costs and the program provided; and

WHEREAS, pursuant to City of San Diego, Council Policy No. 100-05, "User Fee

Policy," the City Council shall approve any revised user fees; and

WHEREAS, in addition to the increase of tuition fee, the SDFD is also requesting to

update the refund policy associated with the program; NOW, THEREFORE,

BE IT RESOLVED, that the City Council of the City of San Diego authorizes an increase

in the tuition cost of the San Diego Junior Lifeguard Program from \$525 per student to \$573 per

student.

BE IT FURTHER RESOLVED, that the City Clerk is authorized to amend the City

Clerk's fee rate book to reflect this tuition cost increase.

BE IT FURTHER RESOLVED, that the Mayor or his designee is authorized to

implement the refund policy attached to this resolution as "Exhibit One."
