A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE ACCEPTANCE OF A DONATION, FROM PARDEE HOMES, OF 74.71 ACRES OF UNDEVELOPED REAL PROPERTY IN THE EAST ELLIOTT AREA OF THE CITY OF SAN DIEGO TO BE MAINTAINED AS OPEN SPACE.

WHEREAS, Pardee Homes, a California corporation (Pardee), has offered to donate to the City of San Diego (City), 74.71 acres of undeveloped real property identified as Assessor's Parcel Numbers 366-050-24, 366-050-28, 366-040-39, and 366-040-41 and located in the East Elliott area of San Diego, north of Mast Boulevard and west of the City of Santee (Property); and

WHEREAS, the City has been acquiring properties for habitat conservation and open space use in this area for several years and the proposed donation is conditioned on the City's use and maintenance of the Property as open space in perpetuity; and

WHEREAS, the appraised value of the Property is \$1,811,500.00; and

WHEREAS, the Real Estate Assets Department has determined that there does not appear to be any potential liabilities associated with the Property; and

WHEREAS, the Parks and Recreation Department has determined that the Parks and Recreation Department can and will assume the maintenance obligations related to the Property; and

WHEREAS, the Real Estate Assets Department has determined that the donation of Property for open space use will benefit the City, and acceptance is in the City's best interest and is consistent with applicable City laws, policies, ordinances, and resolutions; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his designee, is authorized to accept the donation of 74.71 acres of undeveloped real property identified as Assessor's Parcel Numbers 366-050-24, 366-050-28, 366-040-39, and 366-040-41 in the East Elliott area of San Diego, north of Mast Boulevard and west of the City of Santee.

BE IT FURTHER RESOVED, that the Mayor, or his designee, is authorized to execute and deliver all such agreements and other instruments to effect and complete the donation contemplated by this Resolution.
