A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE DEDICATION OF PUBLIC RIGHTS-OF-WAY FOR PORTIONS OF CARROLL CANYON ROAD AND SORRENTO VALLEY ROAD.

WHEREAS, in 2009, the City of San Diego (City) entered into a Cooperative Agreement with the State of California (Caltrans) for the construction of high occupancy vehicle lanes and direct access ramps on Interstate 805 at Carroll Canyon Road and an extension of Carroll Canyon Road from Scranton Road to Sorrento Valley Road; and

WHEREAS, the street improvements were completed and Caltrans has provided the documents necessary to dedicate portions of Carroll Canyon Road and Sorrento Valley Road as right-of-way for street purposes; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his designee, is authorized to take all actions necessary to facilitate the dedication, for street purposes, of a portion of Carroll Canyon Road and a portion of Sorrento Valley Road in that area described as those portions of Pueblo Lot 1352 and Pueblo Lot 1353 both according to Miscellaneous Map No. 36 made by James Pascoe in 1870, a copy of which was filed November 14, 1921, in the Office of the County Recorder of San Diego County, State of California.
