A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING REAPPOINTMENTS TO THE
COMMUNITY REVIEW BOARD ON POLICE PRACTICES.

WHEREAS, San Diego Charter section 43(d) gives the Mayor and City Council exclusive authority to establish a Community Review Board on Police Practices to review and evaluate citizens' complaints against members of the San Diego Police Department and the San Diego Police Department's administration of discipline arising from such complaints; and

WHEREAS, the Community Review Board on Police Practices is established in San Diego Municipal Code Chapter 2, Article 6, Division 11; and

WHEREAS, the Board consists of twenty-three members appointed by the Mayor and confirmed by the Council, who serve two-year terms, and until a successor is duly appointed and qualified; and


WHEREAS, Members of the Board may serve a maximum of eight consecutive years, and after eight consecutive years of service, an interval of two years must pass before a member is eligible to be reappointed; and

WHEREAS, Members of the Board shall be appointed to staggered terms so that the terms of not more than twelve members shall expire in any year; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following reappointments by the Mayor of the City of San Diego, to serve as members of the Community Review Board, for terms expiring as indicated, are made and hereby confirmed:
