

RESOLUTION NUMBER R- 312783

DATE OF FINAL PASSAGE DEC 26 2019

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO RESCINDING RESOLUTIONS R-312600, R-312601, AND R-312602, ALL ADOPTED ON AUGUST 15, 2019, IN CONNECTION WITH AMENDMENTS TO THE SAN DIEGO MUNICIPAL CODE RELATING TO THE INCLUSIONARY AFFORDABLE HOUSING REGULATIONS VETOED BY THE MAYOR ON SEPTEMBER 19, 2019.

WHEREAS, on August 15, 2019, the Council of the City of San Diego (Council) adopted three resolutions in connection with amendments to the San Diego Municipal Code relating to the Inclusionary Affordable Housing Regulations (Inclusionary Ordinance Amendments) considered by the Council at the same time; and

WHEREAS, the Council adopted Resolution R-312600 on August 15, 2019, determining that the Inclusionary Ordinance Amendments were not a project pursuant to the California Environmental Quality Act (CEQA) and were exempt from CEQA pursuant to Section 15183 of the CEQA Guidelines; and

WHEREAS, the Council adopted Resolutions R-312601 on August 15, 2019, approving an economic feasibility analysis of the Inclusionary Ordinance Amendments; and


WHEREAS, the Council adopted Resolutions R-312602 on August 15, 2019, approving the San Diego Housing Commission's revised Inclusionary Affordable Housing Implementation and Monitoring Procedures to implement the Inclusionary Ordinance Amendments; and

WHEREAS, on September 19, 2019, the Mayor vetoed the Inclusionary Ordinance Amendments and therefore Resolutions R-312600, R-312601, and R-312602 related to the Inclusionary Ordinance Amendments are no longer needed; and

WHEREAS, the Council desires to rescind Resolutions R-312600, R-312601, and R-312602; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that Resolutions R-312600, R-312601, and R-312602, all adopted August 15, 2019, are hereby rescinded.


