WHEREAS, the Council of the City of San Diego is considering amendments to the San Diego Municipal Code relating to the Inclusionary Affordable Housing Regulations (Ordinance); and

WHEREAS, since the Ordinance was adopted in 2003, the Council has delegated implementation of the Ordinance to the San Diego Housing Commission (Housing Commission); and

WHEREAS, the Housing Commission implements and administers the Ordinance according to the Inclusionary Affordable Housing Implementation and Monitoring Procedures Manual (Procedures Manual) and has developed a revised Procedures Manual to conform with the amendments to the Ordinance; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the San Diego Housing Commission's revised Inclusionary Affordable Housing Implementation and Procedures Manual, which is on file in the Office of the City Clerk as Document No. RR- 312786 are hereby approved.
