

RESOLUTION NUMBER R- 312790DATE OF FINAL PASSAGE DEC 16 2019A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING THE SELECTION OF A
COUNCIL PRESIDENT PRO TEM

WHEREAS, San Diego Charter section 270(d) provides that the City Council shall have the right to determine its own rules and order of business, including a process for the selection of a Council President to chair Council meetings and manage the docket process, and a President Pro Tem to perform such duties when the President is absent or unable to perform his or her duties; and

WHEREAS, Rule 4.3 of the Rules of the Council, San Diego Municipal Code section 22.0101, provides that the Council President shall select a President Pro Tem, subject to confirmation by a majority of the Council; and


WHEREAS, the Council President Pro Tem shall serve for a term of one year or until a successor is selected and qualified, whichever is later, and the position is not subject to term limits; and

WHEREAS, Council President Georgette Gomez has selected Councilmember Barbara Bry to serve as Council President Pro Tem for a one-year term, or until a successor is selected and qualified, whichever is later, subject to confirmation by the Council; and

WHEREAS, under Charter section 280(a)(1), this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the City Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that after full discussion and deliberation by the City Council, the Council confirms the selection of Councilmember Barbara Bry to serve as Council President Pro Tem for a one-year term commencing on December 16, 2019, or until a successor is selected and qualified, whichever is later, in accordance with the Rules of the Council in the San Diego Municipal Code.

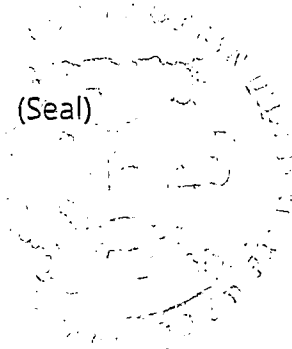


