A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING APPOINTMENTS OF
COUNCILMEMBERS TO THE AUDIT COMMITTEE FOR
CALENDAR YEAR 2020

WHEREAS, San Diego Charter (Charter) section 39.1 establishes an Audit Committee composed of two members of the San Diego City Council (Council) and three public members; and

WHEREAS, Charter section 39.1 provides that the Council shall appoint the two Councilmembers, one of whom shall serve as chair of the Audit Committee; and

WHEREAS, because Charter section 39.1 requires a Councilmember to serve as chair of this committee, if the appointed chair is unable to perform his or her duties, the other Councilmember appointee will serve as the acting chair; and

WHEREAS, Council President Georgette Gomez has nominated two Councilmembers to the Audit Committee for calendar year 2020, with Councilmember Scott Sherman serving as chair and Councilmember Vivian Moreno serving as vice chair, and now asks the Council to confirm the appointments; and

WHEREAS, it is now necessary for the Council to confirm the appointments of the two Councilmembers to the Audit Committee for calendar year 2020; and


WHEREAS, under Charter section 280(a)(6), the Council's confirmation of the appointment of Councilmembers to the Audit Committee is not subject to veto by the Mayor;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that Councilmember Scott Sherman is hereby appointed to the Audit Committee for calendar year 2020 and until a successor is duly appointed and confirmed, and shall serve as the chair of the Audit Committee.

BE IT FURTHER RESOLVED, that Councilmember Vivian Moreno is hereby appointed to serve on the Audit Committee for calendar year 2020 and until a successor is duly appointed and confirmed, and shall serve as vice chair of the Audit Committee.


