A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT BETWEEN PLAINTIFF CALIFORNIA CAPITAL INSURANCE COMPANY AND THE CITY OF SAN DIEGO.

WHEREAS, Plaintiff California Capital Insurance Company filed a complaint, on behalf of their insureds, against the City of San Diego (City) for inverse condemnation on September 11, 2018. Plaintiff alleges property damage caused by a water pipe failure which flooded an apartment complex located at 4055 Hamilton Street, San Diego, California; and

WHEREAS, on November 5, 2019, the City Council by the following votes: Yeas,
Districts 1, 2, 3, 4, 5, 6, 8, and 9; Nays, none; and Absent, 7, approved the settlement of the claim
for an amount consistent with the amounts set forth below; NOW THEREFORE

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

- 1. A resolution authorizing the Mayor or his designee to pay the sum of \$137,331.37 from Water Fund No. 700011, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the inverse condemnation claim filed by California Capital Insurance Company.
- 2. Authorizes the Chief Financial Officer to expend \$137,331.37 from Water Fund No. 700011, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
