DATE OF FINAL PASSAGE DEC 19 2019

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING AN APPOINTMENT TO THE
ETHICS COMMISSION.

WHEREAS, the Ethics Commission (Commission) is established in the San Diego Municipal Code under Chapter 2, Article 6, Division 4 to monitor, administer, and enforce the City's governmental ethics laws, and other duties set forth in that Division; and

WHEREAS, the Municipal Code provides that the Commission shall consist of seven members appointed by the Mayor from a pool of nominees submitted by the members of the City Council and City Attorney, and subject to confirmation by a majority of the City Council; and

WHEREAS, the Municipal Code provides that the members shall serve staggered four-year terms; each member shall serve until a successor is duly appointed and confirmed; and all terms must have expiration dates of June 30; and

WHEREAS, the Municipal Code provides that the Commission shall reflect the diversity of the City, and include: at least one person who has been a candidate for an elective governmental office, has worked as a treasurer or other high-level position in a campaign for elective governmental office, or has held an elective governmental office; and at least three attorneys in good standing with the California Bar Association; and

WHEREAS, the ordinance requires that no more than three members of the Commission shall be registered with the same political party; and


WHEREAS, with the reappointment of William Baber and the continued service of Alex Kreit and Fred Kosmo, three attorneys in good standing with the California Bar Association will be serving on the Commission, meeting the requirements of the Municipal Code; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointments by the Council of the City of San Diego, in compliance with San Diego Charter section 41, to serve as members of the Ethics Commission, for terms expiring as indicated, are made and hereby confirmed:

BE IT FURTHER RESOLVED, by the Council of the City of San Diego, that pursuant to Council Policy 000-13, for purposes of deliberation and consideration of this appointment, it is determined that William Baber is a resident of San Diego County, but not the City of San Diego, and has unique qualifications to serve on the Ethics Commission; therefore, a conscious exception to Council Policy 000-13 is declared.
