DATE OF FINAL PASSAGE APR 09 2020

AN ORDINANCE OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING AGREEMENT BETWEEN CITY
OF SAN DIEGO AND CITY OF EL CAJON TO ALLOW EL
CAJON TO DISCHARGE SEWAGE INTO THE SAN DIEGO
MUNICIPAL SEWERAGE SYSTEM.

WHEREAS, this action will renew the expired agreement for transportation of sewage between the City of San Diego (City) and the City of El Cajon; and

WHEREAS, the City provides wastewater transportation, treatment, and disposal services for the City and 12 adjacent entities known as the Participating Agencies (PAs), which the large sewer mains, pump stations, and treatment plants that convey, treat, and dispose of the sewage for the City and the PAs are referred to collectively as the Metro System; and

WHEREAS, the Metro System services provided to the PAs are governed by the terms and conditions of the Regional Wastewater Disposal Agreement (the Metro Agreement), City Document No. OO-18517, filed May 18, 1998, that remains in force through December 31, 2050; and

WHEREAS, the agreement that stipulates the terms and conditions under which wastewater is transported from the City of El Cajon through the Muni System to the Metro System expired on June 1, 2001, which both agencies agreed to continue to operate under the expired agreement until a new agreement could be memorialized. The new Sewage Transportation Agreement (Transportation Agreement) will replace the expired agreement and it will be in effect through December 31, 2050, to run concurrent with the Metro Agreement; and

WHEREAS, under San Diego Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, an agreement titled, Sewage Transportation Agreement, City of San Diego and City of El Cajon, under the terms and conditions set forth in the Agreement, on file in the Office of the City Clerk as Document No. OO- 21180.

Section 2. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
