AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A THIRD AMENDMENT TO THE SOLE SOURCE AGREEMENT WITH RANCHO JAMUL II HOLDINGS, LLC TO PURCHASE MITIGATION CREDITS.

WHEREAS, the City of San Diego (City) requires compensatory wetland mitigation credits to fulfill environmental regulatory requirements for compensatory mitigation due to impacts with flood control channel maintenance projects performed by the City; and

WHEREAS, in June 2015 the City entered into a Sole Source Agreement with Rancho Jamul II Holdings, LLC (Contractor) to Purchase Mitigation Credits for a total cost of \$1,072,500 for a term of two (2) years (Agreement); and

WHEREAS, in June 2017 the City and Contractor entered into an Amendment to the

Agreement to change the term to four (4) years; and

WHEREAS, in July 2019 the City and Contractor entered into a Second Amendment to the Agreement to change the term to five (5) years; and

WHEREAS, due to the time required for further regulatory permitting review, the City desires to enter into a Third Amendment to the Agreement to change the term to fifteen (15) years; and

WHEREAS, pursuant to San Diego Municipal Code sections 22.3016 and 22.3208, the Purchasing Agent certified the Third Amendment to the Agreement because a competitive process would be unavailing or would not produce an advantage, and that soliciting bids or proposals would be undesirable, impracticable or impossible; and

WHEREAS, under Charter section 99, no contract, agreement, or obligation extending

for a period of more than five (5) years may be authorized except by Ordinance approved by a

two-thirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or designee, is authorized to execute, for and on behalf of the

City, the Third Amendment to Sole Source Agreement with Rancho Jamul II Holdings, LLC to

Purchase Mitigation Credits, under the terms and conditions set forth in the Third Amendment to

the Agreement, on file in the office of the City Clerk as Document No. OO-

Section 2. That a full reading of this Ordinance is dispensed with prior to passage, a

written copy having been made available to the Council and the public prior to the day of its

passage.

Section 3. That this Ordinance shall take effect and be in force on the thirtieth day from

and after its final passage.
