AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO TO AUTHORIZE THE FIFTH AMENDMENT TO THE EMERGENCY MEDICAL SERVICES AGREEMENT WITH AMERICAN MEDICAL RESPONSE, INC.

WHEREAS, the City of San Diego (City) has a contract with American Medical Response, Inc. (AMR) for emergency medical services (EMS Agreement); and

WHEREAS, in the next month, the City anticipates issuing a Request for Proposal (RFP) to solicit proposals from companies that provide emergency medical services; and

WHEREAS, until the RFP solicitation process is completed, the City must extend the EMS Agreement with AMR, the current provider, which expires on June 30, 2020; and

WHEREAS, the City and AMR agree to execute a Fifth Amendment to the EMS Agreement to provide continued emergency medical services until June 30, 2022; and

WHEREAS, the Fifth Amendment to the Agreement contains provisions to provide sufficient time for the City to issue the RFP and transition to emergency medical services under the RFP's new contract terms and conditions, while maintaining public safety and continuity of care of emergency medical services; and

WHEREAS, under Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by ordinance approved by a two-thirds majority of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego as follows:

Section 1. That the Mayor, or his designee, is hereby authorized to execute, for and on behalf of the City, the Fifth Amendment to the current EMS Agreement with AMR under the terms and conditions set forth in the amendment entitled "Fifth Amendment to 2011 Emergency

Medical Services Agreement," on file with the Ci	ity Clerk as Document No. OO -
Section 2. That a full reading of this ordin	ance is dispensed with prior to passage, a
written copy having been made available to the C	Council and the public prior to the day of its
passage.	
Section 3. That this ordinance shall take e	ffect and be in force on the thirtieth day from
