AN ORDINANCE AMENDING CHAPTER 2, ARTICLE 2, DIVISION 5 OF THE SAN DIEGO MUNICIPAL CODE BY REPEALING SECTION 22.0503 AND AMENDING SECTION 22.0506; AMENDING CHAPTER 2, ARTICLE 2, DIVISION 30 BY AMENDING SECTIONS 22.3003, 22.3011, AND 22.3018; AMENDING CHAPTER 2, ARTICLE 2, DIVISION 32 BY AMENDING SECTIONS 22.3202, 22.3206, 22.3208 AND 22.3209, ALL RELATING TO THE PURCHASING AGENT, CONSULTANT CONTRACTS, AND AWARDING CONTRACTS FOR GOODS THROUGH REVERSE AUCTIONS.

WHEREAS, the City of San Diego (City) uses a competitive procurement process to provide for a fair and transparent method of procuring goods, services, and consultants for the City; and

WHEREAS, a reverse auction is a competitive process in which bidders submit bids for prices that they are willing to sell their goods; and

WHEREAS, the use of reverse auctions will broaden and enhance the City's competitive procurement process for goods and save costs; and

WHEREAS, the City desires to amend the San Diego Municipal Code (Municipal Code) to incorporate a reverse auction process for awarding contracts for goods; and

WHEREAS, the City also desires to amend the Municipal Code to clarify the definition of consultant contract and clarify that consultants may not be retained through a cooperative procurement contract; and

WHEREAS, this Ordinance also updates provisions in the Municipal Code, to reflect current operational practices, including changes to the Purchasing Agent's responsibilities for the reporting of disposed assets; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That Chapter 2, Article 2, Division 5 of the San Diego Municipal Code is amended by repealing section 22.0503 and amending section 22.0506, to read as follows:

#### § 22.0506 Obsolete or Depreciated Property—Selling, Disposing

- (a) through (b) [No change in text.]
- (c) The Purchasing Agent shall report in writing, annually, to the Department of Finance all the proceeds from the sale of personal property pursuant to Section 22.0506. The report to the Department of Finance shall describe the property disposed of and state the consideration received by the City for the property.
- Section 2. That Chapter 2, Article 2, Division 30 of the San Diego Municipal Code is amended by amending sections 22.3003, 22.3011, and 22.3018, to read as follows:

### § 22.3003 Definitions

For purposes of this Division and Chapter 2, Article 2, Divisions 30, 31, 32, 33, 34, 35, 36, 38 and 48, the following defined terms appear in italics:

Agency through City's Public [No change in text.]

Consultant contract means a contract for architectural, engineering, or other expert or professional services procured to render advice or an opinion that influences or impacts a municipal decision. Except for contracts with an agency or a non-profit pursuant to Section 22.3210, if the scope of work for a contract for goods or a contract for services includes components that meet the definition of a consultant contract, the requirements for consultant contracts shall control.

Contract for goods through Minor [No change in text.]

Municipal decision has the same meaning as in Section 27.3503.

Public works through Responsible [No change in text.]

Reverse Auction means a competitive process in which bidders submit one or more bids for the prices at which they are willing to sell their goods, and at the end of the auction the bidder offering the lowest price wins.

Sole through Valued [No change in text.]

# § 22.3011 Bid Opening

Section 3. That Chapter 2, Article 2, Division 32 of the San Diego Municipal Code is amended by amending sections 22.3202, 22.3206, 22.3208, and 22.3209, to read as follows:

#### § 22.3202 Competitive Process for Consultant Contracts

Except as otherwise provided in section 22.3208:

- (a) through (e) [No change in text.]
- (f) A consultant shall not be retained through a cooperative procurement contract.

### § 22.3206 Award of Contracts for Goods and Services

- (a) through (b) [No change in text.]
- (c) The Purchasing Agent may award a *contract for goods* through a reverse auction.
- (d) The Purchasing Agent may award a contract for goods or a contract for services that provides for an expenditure of an amount greater than \$3,000,000 provided that:
  - (1) through (3) [No change in text.]
- (e) Unless otherwise provided in this Division, contracts for goods and contracts for services that exceed \$3,000,000 as awarded, amended, or extended, must be approved by the City Council.

# § 22.3208 Contracts Not Required to be Competitively Awarded

The Purchasing Agent may award the following contracts without advertisement or a competitive process:

- (a) through (d) [No change in text.]
- (e) Purchase orders for an expenditure greater than \$25,000 for commercially available materials and supplies provided that they are:

- (2) Less than \$150,000.
- (f) through (g) [No change in text.]

#### § 22.3209 Contracts for Inmate Services

The Purchasing Agent may award a contract for inmate services without City Council approval provided that:

(a) through (c) [No change in text.]

Section 4. That a full reading of this Ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 5. That this Ordinance shall take effect and be in force on the thirtieth day from and after its final passage.

#### §22.0503 Department or Office Estimates of Procurement-Needs

At such times as contracts for supplies are to be let, the head of each department or office of the City shall, when requested by the Purchasing Agent, submit to him an estimate of major articles, commodities, supplies, equipment and materials anticipated to be needed by such department or office for its regular operation during the ensuing fiscal year within the limits of the department's or office's budget.

# § 22.0506 Obsolete or Depreciated Property—Selling, Disposing

- (c) Within five (5) business days after selling or otherwise disposing of personal property pursuant to Section 22.0506, tThe Purchasing Agent shall report in writing, annually, to the Department of Finance City

The City Manager shall report annually in writing to the Council the result of any sales, exchanges or other disposal of personal property made pursuant to Section 22.0506 when the proceeds of the sale exceed five thousand dollar (\$5,000). The report to the council Department of Finance shall describe the property disposed of and state the consideration received by the City for the property.
