AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING EXECUTION OF THE THIRD AMENDMENT TO THE AGREEMENT WITH SAP PUBLIC SERVICES, INC. FOR SOFTWARE LICENSING, MAINTENANCE, SUPPORT AND TECHNICAL ADVISORY SERVICES RELATED TO THE SAP SYSTEMS OF THE CITY OF SAN DIEGO.

WHEREAS, on June 13, 2007, San Diego Data Processing Corporation (SDDPC) and SAP Public Services, Inc. (SAP) entered into an Agreement to provide software licenses, and related maintenance, support and technical advisory services for the SAP suite of programs used by the City for its SAP system (Agreement); and

WHEREAS, pursuant to a separate assignment agreement effective as of January 1, 2012, SDDPC assigned its rights and obligations under the Agreement to the City, and SAP consented to such assignment; and

WHEREAS, Amendment No. 1 to the Agreement was approved by Council Resolution R-307801 and made effective on December 2, 2012; and

WHEREAS, Amendment No. 2 to the Agreement was approved by Council Ordinance O-20578 and made effective on December 10, 2015; and

WHEREAS, the proposed Third Amendment to the Agreement is required to extend the term of the Agreement, provide a not-to-exceed amount for the extension term, and otherwise modify the Agreement as provided for in the Third Amendment; and

WHEREAS, under Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is hereby authorized to execute, for and on

behalf of the City, the Third Amendment to the Agreement with SAP Public Services, Inc. for

software licensing, maintenance, support and technical advisory services for the purpose of

extending the term of the Agreement for an additional five years, providing a not-to-exceed

amount of \$30,492,113 for the extension term, and otherwise modifying the Agreement pursuant

to the terms and conditions contained in the Third Amendment to the Agreement on file with the

21250 Office of the City Clerk as Document No. OO-

Section 2. That the Chief Financial Officer is authorized to expend funds in an amount

not to exceed a total of \$30,492,113 for the remaining term of the Agreement, as amended,

contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal

year and contingent upon the Chief Financial Officer first furnishing one or more certificates

certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasuer.

Section 3. That a full reading of this ordinance is dispensed with prior to its passage, a

written or printed copy having been made available to the City Council and the public prior to

the day of its passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from

and after its final passage.
