AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE TRANSFER AND CONSENT TO ASSIGNMENT OF NON-EXCLUSIVE SOLID WASTE COLLECTION FRANCHISES FROM WASTE MANAGEMENT, INC., DBA BDC SPECIAL WASTE SERVICES TO USA WASTE OF CALIFORNIA, INC., DBA BDC SPECIAL WASTE SERVICES; FROM WASTE MANAGEMENT, INC., DBA EMERALD WASTE AND RECOVERY, INC. TO USA WASTE OF CALIFORNIA, INC., DBA EMERALD WASTE AND FROM WASTE MANAGEMENT, INC., DBA RELIABLE WASTE TO USA WASTE OF CALIFORNIA, INC., DBA RELIABLE WASTE.

WHEREAS, by Ordinance No. O-19180, adopted on May 20, 2003, the City Council authorized the execution of a new Class II non-exclusive franchise agreement with Waste Management Inc., dba BDC Special Waste Services (BDC) to provide solid waste management services within the City (BDC Franchise); and

WHEREAS, on July 1, 2003, the City and BDC entered into a Class II Non-Exclusive Franchise Agreement for Solid Waste Management Services (BDC Agreement), which is on file in the Office of the City Clerk as Document No. OO-19180-2 A through J; and

WHEREAS, the BDC Agreement has since been amended seven times; and

WHEREAS, the parties became aware of a discrepancy in the name of the legal entity that holds the BDC Franchise, and the City determined that a Franchise Transfer is necessary to correct that discrepancy; and

WHEREAS, USA Waste of California, Inc., dba BDC Special Waste Services (USA BDC) has filed a franchise application to transfer the BDC Franchise from BDC to USA BDC

and assign the BDC Agreement, as amended, to USA BDC (Consent to Assignment of BDC); and

WHEREAS, by Ordinance No. O-19180, adopted on May 20, 2003, the City Council authorized the execution of the Class I non-exclusive franchise agreement with Emerald Waste and Recovery, Inc. (Emerald), to provide solid waste management services within the City (Emerald Franchise); and

WHEREAS, on July 1, 2003, the City and Emerald entered into the Class I Non-Exclusive Franchise Agreement between the City of San Diego and Emerald Waste and Recovery, Inc., for Solid Waste Management Services (Emerald Agreement), which is on file in the Office of the City Clerk as Document No. OO-19180-1 A through J; and

WHEREAS, by Ordinance No. O-20029, adopted on March 11, 2011, the City Council authorized the transfer of the Emerald Franchise to Waste Management of California, Inc., dba Emerald Waste and Recovery, a Class II non-exclusive franchise, for the collection and management of solid waste; and

WHEREAS, the Emerald Agreement has been amended seven times; and
WHEREAS, the parties became aware of a discrepancy in the name of the legal entity
that holds the Emerald Franchise, and the City determined that a Franchise Transfer is necessary
to correct that discrepancy; and

WHEREAS, USA Waste of California, Inc., dba Emerald Waste and Recovery (USA Emerald) has filed a franchise application to transfer the Emerald Franchise from Waste Management of California, Inc. to USA Emerald and assign the Emerald Agreement, as amended, to USA Emerald; and

WHEREAS, by Ordinance No. O-19180, adopted on May 20, 2003, the City Council authorized the execution of a new Class II non-exclusive franchise agreement with Waste Management, Inc., dba Reliable Waste (Reliable) to provide solid waste management services within the City (Reliable Franchise); and

WHEREAS, on July 1, 2003, the City and Reliable entered into the Class II Non-Exclusive Franchise Agreement between the City of San Diego and Reliable Waste, for Solid Waste Management Services (Reliable Agreement), which is on file in the Office of the City Clerk as Document No. OO-19180-2 A through J; and

WHEREAS, the Reliable Agreement has since been amended seven times; and
WHEREAS, the parties became aware of a discrepancy in the name of the legal entity
that holds the Reliable Franchise, and the City determined that a Franchise Transfer is necessary
to correct that discrepancy; and

WHEREAS, USA Waste of California, Inc., dba Reliable Waste (USA Reliable) has filed a franchise application to transfer the Reliable Franchise from Reliable to USA Reliable and assign the Agreement, as amended, to USA Reliable; and

WHEREAS, the Consent to Assignment of the BDC Franchise, the Emerald Franchise, and the Reliable Franchise will result in a transfer of a franchise as defined under San Diego Charter section 103; and

WHEREAS, the transfer of a franchise requires City Council approval under San Diego Charter section 103, San Diego Municipal Code section 66.0120, and article 10.5 of the franchise agreements; and

WHEREAS, under San Diego charter section 103, no franchise transfer may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; and

WHEREAS, this item was heard by the Environment Committee on September 24, 2020, which unanimously recommended approval of these transfers; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the transfer of the Class II Non-Exclusive Franchise for Solid Waste

Management Services from Waste Management Inc., dba BDC Special Waste Services to USA

Waste of California, Inc., dba BDC Special Waste Services is hereby approved.

Section 2. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, a consent to the assignment of the BDC Special Waste Services Franchise and the franchise agreement, as set forth in the Consent to Assignment of Class II Non-Exclusive Franchise Agreement for Solid Waste Management Services, on file with the City Clerk as Document No. OO- 21252.

Section 3. That the transfer of the Class II Non-Exclusive Franchise for Solid Waste
Management Services from Waste Management Inc., dba Emerald Waste and Recovery to USA
Waste of California, Inc., dba Emerald Waste and Recovery is hereby approved.

Section 4. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, a consent to the assignment of the Emerald Waste and Recovery Franchise and the franchise agreement, as set forth in the Consent to Assignment of Class II Non-Exclusive Franchise Agreement for Solid Waste Management Services, on file with the City Clerk as Document No. OO- 21252.-2

Section 5. That the transfer of the Class II Non-Exclusive Franchise for Solid Waste Management Services from Waste Management, Inc., dba Reliable Waste to USA Waste of California, Inc., dba Reliable Waste is hereby approved.

the City, a consent to the assignment of the Reliable Waste Franchise and the franchise

agreement, as set forth in the Consent to Assignment of Class II Non-Exclusive Franchise

Agreement for Solid Waste Management Services, on file with the City Clerk as Document No.

Section 8. That this ordinance shall take effect and be in force on the thirtieth day from
