A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
PLAINTIFF SIKEYAA ROBINSON AND THE CITY OF SAN
DIEGO.

WHEREAS, Plaintiff Sikeyaa Robinson filed a complaint against the City of San Diego on March 7, 2018, alleging personal injuries arising from the trip and fall that occurred on El Cajon Boulevard and 34th Street. Plaintiff brought suit in the San Diego Superior Court. The suit is entitled *Sikeyaa Robinson v. City of San Diego*, Case No. 37-2018-00011555-CU-PO-CTL [Litigation]; and

WHEREAS, on November 19, 2019, the City Council by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 8, 9; Nays, none; and Absent, 7, approved the settlement of the claim for an amount consistent with the amounts set forth below; NOW THEREFORE


BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$72,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the personal injury damage claim of *Sikeyaa Robinson v. City of San Diego*, San Diego Superior Court Case 37-2018-00011555-CU-PO-CTL.

2. Authorizes the Chief Financial Officer to expend \$72,000.00 from Public Liability Fund No. 720045, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. Authorizes the Department of Finance to issue one check in the sum of \$61,828.08, made payable to Deon Goldschmidt Attorneys, APC, for the benefit of Sikeeya Robinson; and one check in the sum of \$10,171.92, made payable to The Rawlings Company.


