A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE RETENTION OF HUGO PARKER, LLP AS AN OUTSIDE COUNSEL CONSULTANT AND APPROVING AN AGREEMENT FOR CONSULTING SERVICES WITH HUGO PARKER, LLP.

WHEREAS, the City seeks to retain the Law Firm of Hugo Parker, LLP as an outside counsel consultant in regards to any issues involving asbestos containing material at any City owned or occupied building or facility; and

WHEREAS, on January 8, 2020, the Purchasing Agent approved the Request and Certification for Sole Source Procurement; and

WHEREAS, Hugo Parker, LLP (Law Firm) has the necessary skills and experience to assist the City in asbestos-related matters; and

WHEREAS, the agreement for legal services (Legal Services Agreement) accompanying this Resolution, between the City and the Law Firm is for an amount not to exceed \$150,000 for a two-year term; and

WHEREAS, the funding for the Legal Services Agreement shall be borne by: 1). the General Fund or Public Liability Fund when approved by Risk Management, or 2). the City Department seeking Law Firm's consulting services; and

WHEREAS, on October 8, 2019, the Law Firm of Hugo Parker, LLP was retained as outside counsel to represent the City and City employee Ronald Villa in *Alina Cadena, et al.* v. City of San Diego, et al., Case No. 37-2019-00032076-CU-MC-CTL pursuant to a four-year agreement not to exceed \$300,000; and

WHEREAS, due to Law Firm's retention in the above-referenced litigation, the overall award to this consultant will exceed \$250,000, and City Council approval of this consultant

agreement is required pursuant to San Diego Municipal Code section 22.3207(a)(2).;

NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:

1. That the City Attorney is authorized to retain the Law Firm as an outside counsel

consultant in regards to any issues involving asbestos containing material at any City owned or

occupied building or facility.

2. That the Legal Services Agreement is approved and the Mayor or his designee is

authorized to execute for and on behalf of the City of San Diego, an agreement for legal services

with the Law Firm for consulting services, in an amount not to exceed \$150,000 for a two-year

term, under the terms and conditions set forth in the Legal Services Agreement.

3. That the Chief Financial Officer or his designee is authorized to appropriate and

expend an amount not to exceed \$150,000 for the above Legal Services Agreement (1) from the

General Fund or the Public Liability Fund, as may be approved by Risk Management and

contingent upon the adoption of the Appropriation Ordinance for the applicable Fiscal Year, and

contingent upon the Chief Financial Officer first issuing one or more certificates certifying that

the funds necessary for expenditure are, or will be, on deposit in the City Treasury; or, (2) the

City Department seeking Law Firm's consulting services shall approve and coordinate payment

for such services from its funds.
