WHEREAS, the IBA has prepared its Report dated January 16, 2020 entitled "FY 2021 City Council Budget Priorities" (FY 2021 Budget Priorities Report), incorporating the budget priorities of the individual Councilmembers; and

WHEREAS, on January 22, 2020, the Budget and Government Efficiency Committee (Committee) voted to forward the FY 2021 Budget Priorities Report to the City Council for approval; and

WHEREAS, pursuant to San Diego Charter sections 280(a)(1) and 295(b), this resolution is exclusively within the purview of the City Council and may be passed by the City Council on the date of introduction, which date shall be deemed the date of final passage, and is not subject to veto by the Mayor; NOW, THEREFORE,

BE IT RESOLVED by the Council of the City of San Diego that the FY 2021 Budget Priorities Report concerning City Council budget priorities for the Fiscal Year 2021 Budget, is hereby accepted, and the IBA is hereby directed to deliver that report, together with each Councilmembers' Fiscal Year 2021 Budget Priorities Memorandum, to the Mayor's Office for consideration during the preparation of the Fiscal Year 2021 proposed budget.
