A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING FUNDS FOR ALLIED GARDENS COMMUNITY EVENTS, KIWANIS FOUNDATION OF TIERRASANTA, AND LAKE MURRAY FIREWORKS AND EVENTS PURSUANT TO COUNCIL POLICY 100-23, TITLED "CITY COUNCIL FUNDING FOR ARTS, CULTURE AND COMMUNITY FESTIVALS WITH DISCRETIONARY TRANSIENT OCCUPANCY TAX ALLOCATION."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-23, titled "City Council Funding of Arts, Culture and Community Festivals with Transient Occupancy Tax Allocation" on August 13, 2012, by Resolution R-307625; and

WHEREAS, Council Policy 100-23 provides a procedure and uniform requirements for awarding funds to and contracting with private non-profit organizations that produce programs, projects and events that (i) provide access to excellence in culture and the arts for residents of, and visitors to, San Diego, and (ii) enrich the lives of the people of San Diego and build healthy, vital neighborhoods; and

WHEREAS, the City received and evaluated three applications for Arts, Culture and Community Festivals (ACCF) funding for the following purposes:

Lake Murray Fireworks and Events	MusicFest	celebration by funding a stage and the lighting costs for a family friendly event.

WHEREAS, it is the determination of the City Council that the above-described programs are consistent with the parameters outlined in Council Policy 100-23; and

WHEREAS, Council District 7 recommends an allocation of \$7,500 to Allied Gardens

Community Events for support and supplies for the event set forth in this resolution; and

WHEREAS, Council District 7 recommends an allocation of \$4,000 to the Kiwanis

Foundation of Tierrasanta for support and supplies for the event as set forth in this resolution;
and

WHEREAS, Council District 7 recommends an allocation of \$10,000 for the stage and lighting costs for Lake Murray Fireworks and Events as set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocations described in this resolution are made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-23, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any goods, supplies, or materials which have already been purchased."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, ACCF FY 2020 City Council Allocation Agreements between the City of San Diego and (1) Allied Gardens Community Events in an

amount not to exceed \$7,500, (2) the Kiwanis Foundation of Tierrasanta in an amount not to exceed \$4,000, and (3) Lake Murray Fireworks and Events in an amount not-to-exceed \$10,000 for the events described in this resolution, under terms and conditions set forth in the Agreements on file in the Office of the City Clerk as Document No. RR-312836 for Allied Gardens Community Events, Document No. RR-312836 for the Kiwanis Foundation of Tierrasanta, and Document No. RR-312836 for Lake Murray Fireworks and Events.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$21,500 from the ACCF budget Fund No. 200205, Cost Center 1414111218 GL512059, to provide funds for the above-referenced Agreements, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
