A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
PLAINTIFF, ALARICE KING AND THE CITY OF SAN
DIEGO.

WHEREAS, Plaintiff Alarice King filed a complaint against the City of San Diego (City) for sexual harassment and racial discrimination resulting from allegations of violations of the Fair Employment and Housing Act. Plaintiff brought suit in the Superior Court of the County of San Diego. The suit is entitled *Alarice King v. City of San Diego*, San Diego Superior Court Case No. 37-2018-00041485-CU-PO-CTL [Litigation]; and

WHEREAS, on December 17, 2019, the City Council by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7 and 9; Nays, none; and Absent, 8, approved the settlement of the claim for an amount consistent with the amounts set forth below;

NOW THEREFORE BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$250,000.00 from the Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type including attorney fees, against City of San Diego, its agents and employees, arising from the sexual harassment and racial discrimination claim filed by Plaintiff, Alarice King for violations of the Fair Employment and Housing Act entitled, *Alarice King v. City of San Diego*, San Diego Superior Court Case No. 37-2018-00041485-CU-PO-CTL [Litigation];

2. Authorizes the Chief Financial Officer to expend \$250,000.00 from Public Liability Fund No. 720045, contingent upon the Chief Financial Officer first furnishing one or

more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. Authorizes the Department of Finance to issue a check in the amount of \$250,000.00, made payable to the Law Offices of Stephen B. Morris FBO Alarice King.
