A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AUTHORIZING EXECUTION OF AN  
AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND  
INDUSTRIAL/ORGANIZATIONAL SOLUTIONS FOR POLICE  
PROMOTIONAL EXAMINATIONS AND CONSULTING  
SERVICES.

WHEREAS, on August 31, 2017, the City issued a Request for Proposal No. 10088290-18-F, soliciting proposals for qualified providers to create and administer the police promotional examinations; and

WHEREAS, on March 27, 2018 Industrial/Organizational (IO) Solutions was awarded the contract for a two-year term through March 27, 2020, with three additional one-year option periods; and

WHEREAS, City Council approval is now required based on the projected total amount of the contract in accordance with Municipal Code section 22.3207; and


WHEREAS, the Public Safety and Livable Neighborhoods Committee heard this item on January 29, 2020 and unanimously recommended Council approval; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor, or his designee, is authorized to execute, for and on behalf of the City, the Agreement between the City of San Diego and IO Solutions for the provision of providing police promotional examinations, in amount not to exceed \$500,000 over the term of the Agreement.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend funds in an amount not to exceed \$500,000, from the General Fund, over the term of the Agreement, contingent upon the adoption of the Annual Appropriations Ordinance for the

applicable fiscal year, and contingent upon the Chief Financial Officer first furnishing a certificate certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
