A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING FUNDS FOR ARTS, CULTURE AND COMMUNITY FESTIVALS FUNDING TO BLINDSPOT COLLECTIVE FOR ITS SCHOOL & COMMUNITY TOUR SHOWS PURSUANT TO COUNCIL POLICY 100-23, TITLED "CITY COUNCIL FUNDING FOR ARTS, CULTURE AND COMMUNITY FESTIVALS WITH DISCRETIONARY TRANSIENT OCCUPANCY TAX ALLOCATION."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-23, titled "City Council Funding of Arts, Culture and Community Festivals with Transient Occupancy Tax Allocation" on August 13, 2012, by Resolution R-307625; and

WHEREAS, Council Policy 100-23 provides a procedure and uniform requirements for awarding funds to and contracting with private non-profit organizations that produce programs, projects and events that (i) provide access to excellence in culture and the arts for residents of, and visitors to, San Diego, and (ii) enrich the lives of the people of San Diego and build healthy, vital neighborhoods; and

WHEREAS, the City received and evaluated an application for Arts, Culture and Community Festivals (ACCF) funding from Blindspot Collective, as follows:

WHEREAS, it is the determination of the City Council that the above-described programs are consistent with the parameters outlined in Council Policy 100-23; and

WHEREAS, Council District 9 recommends an allocation of \$3,000 of its ACCF funding allocation to Blindspot Collective for its School & Community Tour Shows for support of and supplies for the event as set forth in this resolution; and

WHEREAS, Council District 4 recommends an allocation of \$2,000 of its ACCF funding allocation to Blindspot Collective for its School & Community Tour Shows for support of and supplies for the event set forth in this resolution; and

WHEREAS, Council District 8 recommends an allocation of \$2,000 of its ACCF funding allocation to Blindspot Collective for its School & Community Tour Shows for support of and supplies for the event set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocations described in this resolution are made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-23, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any goods, supplies, or materials which have already been purchased."

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-23, section 4, which provides: "ACCF funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued."

directed to execute, for and on behalf of the City, ACCF FY 2020 City Council Agreements

between the City of San Diego and Blindspot Collective for its School & Community Tour

and conditions set forth in the Agreement on file in the Office of the City Clerk as Document

No. RR- 312864 for ACCF funding to Blindspot Collective for its School & Community

Tour Shows.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend

a total amount not to exceed \$7,000 from the ACCF budget Fund No. 200205, Cost Center

1414111215 GL512059 (\$2,000 from District 4), Fund No. 200205, Cost Center 1414111219

GL512059 (\$2,000 from District 8), and Fund No. 200205, Cost Center 1414111220 GL512059

(\$3,000 from District 9) to provide funds for the above-referenced Agreement, contingent upon

the Chief Financial Officer first furnishing one or more certificates certifying that the funds

necessary for expenditure are, or will be, on deposit with the City Treasurer.
