A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING FUNDS FOR SOMALI BANTU ASSOCIATION OF AMERICA FOR ITS RAJA=HOPE PROGRAM PURSUANT TO COUNCIL POLICY 100-23, TITLED "CITY COUNCIL FUNDING FOR ARTS, CULTURE AND COMMUNITY FESTIVALS WITH DISCRETIONARY TRANSIENT OCCUPANCY TAX ALLOCATION."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-23, titled "City Council Funding of Arts, Culture and Community Festivals with Transient Occupancy Tax Allocation" on August 13, 2012, by Resolution R-307625; and

WHEREAS, Council Policy 100-23 provides a procedure and uniform requirements for awarding funds to and contracting with private non-profit organizations that produce programs, projects and events that (i) provide access to excellence in culture and the arts for residents of, and visitors to, San Diego, and (ii) enrich the lives of the people of San Diego and build healthy, vital neighborhoods; and

WHEREAS, the City received and evaluated an application for Arts, Culture and Community Festivals (ACCF) funding from Somali Bantu Association of America, as follows:

ORGANIZATION	PROGRAM/ACTIVITY	PUBLIC BENEFIT
Somali Bantu Association of America	RAJA=HOPE	This festival will bring together members of the public, including Somali-Bantu residents, to learn about Somali-Bantu culture, including traditional foods, music, and dance.

WHEREAS, it is the determination of the City Council that the above-described programs are consistent with the parameters outlined in Council Policy 100-23; and

WHEREAS, Council District 9 recommends an allocation of \$2,500 of its ACCF funding to Somali Bantu Association of America Community Event for its RAJA=HOPE program support of and supplies for the event set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution are made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-23, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any goods, supplies, or materials which have already been purchased."

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-23, section 4, which provides: "ACCF funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, ACCF FY 2020 City Council Agreement between the City of San Diego and Somali Bantu Association of America in an amount not-to-exceed \$2,500 for the event described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-312865 for ACCF funding to the Somali Bantu Association of America.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$2,500 from the ACCF budget Fund No. 200205, Cost Center 1414111220 GL512059 to provide funds for the above-referenced Agreement, contingent upon

the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
